She will begin her employment with the District on March 2, 2026, as the Treatment Supervisor to enable her to become familiar with the District. Current General Manager Ed Holt will remain at this position through June and then work part-time in the position of Distribution Supervisor for at least one year to ensure a successful transition of management.
